A quorum of Board members was announced, and the meeting was called to order at 6:31 p.m.

MINUTES APPROVAL

The meeting minutes from June 23, 2022 were unanimously approved, pending one edit. Motion – Jeramy, second – Todd; all in favor 3-0

FINANCIAL REPORT

The Board was presented with the May 2022 financials.

BUSINESS

- Spectrum provided an update to the Transfer Pump repairs. Aqualis was scheduled to perform the inspection on the transfer pump during the week of June 20, 2022. Currently, the Board is awaiting the inspection report to determine what work needs to be completed to repair the pump.
- The Board of Directors approved the proposal from McKenna Contracting in the amount of \$9,250.00 + tax to resurface the tennis court. The Board requested that the project be scheduled for a time that will least impact the homeowners that utilize the court.

 about the pool rules and stated that the pool rules located on the Brittany Lakes website and onsite are
 different. These will be updated to be consistent and Spectrum informed that the trees mentioned are a part
 of the ongoing bid solicitation for tree removal and replacements.
- Mark Buehler provided positive feedback to the Board of Directors regarding the mailbox repaint project.
 Mark also inquired about the status of the Landing/League City Parkway construction. Spectrum will work to provide an update on this situation as soon as possible to homeowners.
